AUDITION INFORMATION:

- There is a new candidate parent meeting on March 27th and April 24th at 7pm at Klein Oak.
- You **WILL NOT** need a physical to audition. However, if you make the team you WILL need one prior to camp at the end of July. This is an activity that is very strenuous. If you have any physical restraints, you might need to be checked by a physician. All physicals must be completed on the KISD physical form for 2018/2019 and are available through the Athletic Department at your school and online.
- **Audition Workshop:** April 30th through May 4th in the large gym from 3-5pm for returning members and from 5:00-7:00pm for new candidates. The audition skills and dance will be taught during these times only.
- **Auditions:** Saturday, May 5th beginning at 9:00 AM

AUDITION INFORMATION

WHAT TO WEAR – AUDITION WORKSHOP:

- Dance attire – black dance pants, capris or hot shorts with a black cami, tank top with no midriff showing or black leotard
- Toe Paws, Pirouettes, Tan Jazz Shoes or Barefoot
- Hair in a ponytail, out of your face and off of your neck
- No jewelry, no gum, no cheer or athletic style shorts

WHAT TO WEAR – AUDITIONS:

- New Candidates: Black Leotard, Black Hot Shorts and either Toe Paws, Pirouettes, Tan Jazz Shoes or Barefoot
- Returning Members: Black Leotard, Black Hot Shorts & Pirouettes
- Hair in a high bun, slicked down, no bangs
- Full PERFORMANCE make-up (dark red/maroon lipstick, dark blush, lots of black eye liner, black eye shadow in the crease with white on the lid and by the brow, black mascara, and foundation and powder matching your skin tone!)
- No jewelry of any kind!

CANDIDATES WILL BE SCORED ON THE FOLLOWING AREAS:

- Kicks (Straights, Fans, Exercise Kicks, Angle Kicks & an Extension)
- Rhythm / Coordination
- Technique
- Splits
- Showmanship / Projection
- Ability / Potential / Memory
- Dance Skills: Center leap (jete' in 2nd position), calypso (jete' in attitude), double pirouette, a la seconds (3 turns in second into a double pirouette), a jete' (Right and Left), a tilt leap and a Toe Touch. All of these skills will be taught at the workshop and reviewed each day. Each skill is right side dominate for this tryout except for the jetes. They will be both right and left.
- Promptness, Work Ethic and Attitude throughout the workshop will also be evaluated.

REMINDERS:

- The Workshop and Auditions are closed to the public. No parents or spectators will be allowed in the gym during this time. Parents are encouraged to be with their daughters when they receive their envelope at the end of the auditions letting them know if they have or have not been selected as a member of the Strutters.
- If you are not selected for the team, please do not approach the judges, the Coaches, or anyone else involved at that time. Please schedule a conference no sooner than one week following the audition to see the areas in need of improvement.
- Anyone who does not make Strutters should consider trying out for the color guard or signing up for the Dance 1 Strutter Training Class period to prepare for the next set of auditions.
- Have a good attitude, stay positive, keep the faith, be on time to start, be picked up on time and always use your manners! Good luck and remember to SMILE and HAVE FUN!!

IMPORTANT STRUTTER INFORMATION

- Every Strutter auditions for every dance and not every Strutter will perform every dance.
- Every practice, performance and event is mandatory. Routine doctor appointments, family gatherings/vacations, court dates, driver's education classes, rodeo, etc....are not excused and demerits will be given. The only excused absences are for illness, school events with prior director approval or a death in the family. Missing practices and performances will result in being replaced by an alternate if a viable alternate is available except in cases of an immediate family member's funeral. Unexcused absences result in demerits and possible probation.
- All expenses must be paid on time in order for your daughter to be selected for the upcoming dances. Extenuating circumstances must be brought to the director in a timely manner and payment plans must be adhered to.
- Disciplinary infractions will be handled by the director and administration as necessary. Please see the constitution for more information regarding demerits, merits, probation and removal from the team. This can be found at www.kleinoakstrutters.com
- Communication is key! I expect my Strutters to learn to communicate with their officers and coaches regarding questions, concerns, etc. From that point, parents may contact me to discuss their questions/concerns as needed. We all follow the chain of command or "pecking order" from the team to the officers, directors and then KO administration, if necessary.
- Education comes first and I expect Strutters to be responsible for their grades, conduct and academic achievement. Every Strutter must be passing their classes with a 70 or above to participate and remain eligible. Some classes are waived for eligibility however my expectation is that they should be passing regardless.
- To be eligible for football season, every Strutter must complete dance hours over the summer. The number of required hours will be announced at induction/vendor night.
- Every Strutter must complete 30 hours of community service as part of their grading period average. More details will be given at induction/vendor night.
- As part of the Strutters overall grade, every Strutter family is required to volunteer a set number of hours throughout the year at designated fundraisers, functions and contest

SUMMER DATES

During the last week of July, we have Dance Rage which is the beginning of our camps. The first week of August, officers will have planning sessions. The second week of August we will have master choreography classes at the school, the family picnic and then go on a team retreat for team building and fun to kick off our year! Dates and times will be announced at induction. All of these events are mandatory. Scheduling conflicts during these weeks must be discussed with Coach Polansky before auditions to see if there are other options. Not attending camps, removes the member from the team. Not attending practice will result in demerits and being benched from performances. Not completing required dance hours will result in being benched from performances as well until all hours are completed.

The Klein Oak Strutter booster club is a parent organization that provides support to the director and the team. This organization strives to create a family atmosphere where everyone is welcome to join in on the festivities. There are many opportunities to bond with other families and support your Strutter at the same time. We have several committees you can be a part of... props, costuming, spirit, class reps, banquet, ball, KO contest, golf tournament, etc.

WE HAVE SOMETHING FOR EVERYONE!

The booster club participates in three fundraisers throughout the year to help raise funds for goodies for the team, props, storage, scholarships, Strutter ball, banquet and more. The booster club fee is estimated at \$150 depending on the number of girls on the team. This may be paid in full or can be broken down into a payment plan. The booster club requires 4 donations (approximately \$25 each) per family throughout the year to help with the golf tournament, AAYFDT host competition and MA dance / KO host contest. These can be gift cards, food donations, monetary donations or even sponsorships from your local businesses. We like to involve our community in our goals and they love supporting such a wonderful group of young ladies. If you would rather write a check than have to worry about collecting donations or participating in fundraisers, you may do so to the sum of \$400. We appreciate everyone's support no matter how you wish you participate.

To sum it all up, the more parent participation we have, the lower the overall cost will be and the more fun everyone will have. We appreciate the huge amount of support we receive from our current members along with our alumni. We hope you will join us in supporting our Strutters throughout the year and in the years to come by being a booster club member.

Throughout the year we ask parents to volunteer in many different facets. We need dads (and moms) to help build props, transport props and set up and take down curtains. We need moms (and dads) to help bling, wash and make costume pieces. PARENT PERMISSION FORM (FOR THOSE AUDITIONING FOR STRUTTERS)

- I understand the commitment involved in my daughter becoming a Strutter and do give my permission for her to do so.
- I understand that as a member of the team, she is expected to abide by the guidelines approved by the district which are listed in this contract and the Constitution.
- I understand that she must attend all practices, performances, camps and mandatory events throughout the year and if she does not, there will be consequences.
- I understand that her dance ability, effort, grades, attitude, organization, and discipline are all factors to be considered in making each / any performance.
- I understand that if my daughter is selected for Strutters this does not guarantee her spot in the dances and that not every Strutter will be selected for every performance.
- I understand that she must try out for every dance and maintain her grades, dance ability and have exemplary conduct to be selected to perform.
- I understand that all fees and dues must be paid on time regardless of my daughter's selection in performances, probation, grades, conduct, etc.
- I understand that the fees specified must be paid on time for my daughter to be able to audition for the upcoming dances and participate in the upcoming performances.
- I understand that removal from the team results in forfeit of funds paid without reimbursement and does not release the Strutter from balances they still owe.
- I understand that if my daughter is removed or removes herself from the team, she may not wear the Strutter attire or logo representing the Strutters from that point on.
- I understand that the Strutters practice every day after school and on selected Saturdays and that every practice is mandatory.
- I understand that if a Strutter misses a practice she will be removed from the dance and replaced by an alternate if a viable alternate is available until another spot becomes available and she is able to try out for that open spot.
- I understand that Strutters is a year round sport and fine art that will require time, commitment and effort by my daughter and myself.
- I understand that my daughter must travel with the team to all football performances, camps, special appearances, workshops and regional, state and national competitions.
- I release the school and district of all liabilities during the workshop and auditions.
- I furthermore understand that a physical for my daughter is required once she makes the team and that payment plans begin on Vendor Night.
- I understand that all Strutters are held to the highest of standards in and out of uniform and that poor decisions involving social media, cursing, alcohol, drugs and/or lewd behavior, regardless if it is at a Strutter function or not, will result in consequences ranging from demerits to dismissal from the team at the coach's discretion.
